NOTICE OF PRIVACY

Below you will find the Privacy Policy of the personal data collected through www.itn.travel.

At INTERNATIONAL TRAVEL NETWORK we understand that booking online requires a lot of trust on your part. We value your trust, which is why one of our highest priorities is ensuring the security and confidentiality of the personal information you provide us. Please read this document carefully to learn about our privacy practices. By visiting this website, you are accepting the practices described here.

In General: We receive and store all the information that you enter on our website or that you provide in any other way. This includes information that can identify you ("personal information"), including your first and last name, telephone number, postal and email address, fax number, and billing information (such as credit card number, cardholder name and expiration date). We may also request information about your hotel room preferences and information about your airline or car rental loyalty program. You may choose not to provide information to us, but generally certain information is required from you in order for you to become a member; make travel reservations; fill out a traveler profile; participate in surveys, contests or sweepstakes; ask us a question; or perform other operations on our site.

Companion Information: When you make a reservation for other people through this website, we will ask for your personal information and travel preferences. You must obtain the consent of other people before providing your personal data and travel preferences on this website, as access to view or modify the information will only be available through your account.

We use sensitive billing information (such as cardholder name, credit card number, and expiration date) for the purposes of completing the reservations you make on our site. We use other information about you for the following general purposes: to provide you with the products and services you request; to provide you with travel confirmations and updates; to manage your account, including notes or invoices and to provide you with travel notices; to communicate with you; to answer your questions and comments; to measure your interest in and improve our products, services and site; and improve them; to notify you of products, services and special offers that may interest you; to personalize your experience on this site; to reward you as part of any loyalty or rewards program you choose to be a part of; to request information from you, including through surveys; to resolve disputes or problems or collect compensation; to prevent potentially illegal or prohibited activities; to enforce our Terms of Use; and for any other purpose that is informed at the time of requesting information.

This site may share your information with the following entities:

- Suppliers, such as hotels, airlines, car rental companies and other tourism service providers, who fulfill your tourism reservations. Throughout this site, all services that are provided by a third party are identified as such. We do not impose limitations on a provider's use or disclosure of your personal information. Therefore, we urge you to review the privacy policies of any tourism service provider whose products are purchased through this site. Please note that it is possible for these providers to contact you directly to obtain more information about you, provide your travel reservation or respond to a review submitted by you.
- Independent vendors who provide services or functions on our behalf, including credit card processing, business analysis, customer services, marketing, distribution of surveys or contest programs, and fraud prevention. In addition, we may authorize independent vendors to collect information on our own, including that which is necessary to operate functions of our site or to facilitate the delivery of online advertising tailored to your interests. Third parties will only have access to and may collect information exclusively to perform their functions, and they are not permitted to use or share such information for other purposes.
- Business partners with whom we may jointly offer products and services, or whose products and services may be offered on our site. You will notice when a third party has a relationship with a product or service requested by you because their name will appear separately or jointly with ours. If you choose to access these optional services, we may share your information, including your personal information, with those partners. Please note that we do not control the privacy practices of business partners.
- Companies of our corporate group. We may share your information with our corporate affiliates. This allows us to provide you with information on products and services, related or not to travel, that may be of interest to you. To the extent that our corporate affiliates have access to your information, they will follow practices that are at least as restrictive as those contained in these Privacy Policies. Likewise, they will comply with all legal provisions related to the transmission of advertising materials and, at a minimum, will give you the opportunity in any commercial email to choose to stop receiving advertising materials later.

We may also share your information:

In response to or response to court orders or derived from other legal procedures; to establish or exercise our rights; to defend ourselves against legal claims; or in any other way that is required according to the applicable laws. In these cases, we reserve the right to assert or waive any right or exception that may assist us.

- When we consider it convenient to investigate, prevent or take action in relation to illegal or presumably illegal activities; to safeguard and defend the rights, property or safety of our company or this site, our clients or third parties; and in connection with our Terms of Service and other contracts.
- In relation to a corporate operation, such as a divestiture, merger, consolidation, sale of assets or in the event of a bankruptcy proceeding.

- The Help section of most browsers will tell you what to do to prevent the browser from accepting new cookies, for the browser to notify you when you receive a new cookie, or to disable cookies. Please note that if you decline to receive cookies, you may not have access to most of the travel tools on our site.
- We want you to feel safe using this site to make your travel reservations, so we are committed to safeguarding the information we collect. Although no website can guarantee security, we have implemented security procedures of an administrative, technical and material nature, necessary to safeguard the personal information that you provide us. For example, only authorized employees can have access to your personal information and they can only do so for specific reasons within their duties. Additionally, we use encryption when we transmit your personal information between your system and ours, and we use firewalls and intrusion detection systems to prevent unauthorized persons from gaining access to your personal information.
- This is a site intended for a general audience and does not offer services intended for minors. In the event that we become aware that a person under 18 years of age sends us personal information, we will use that information exclusively to inform that minor that we require the consent of their parents to receive their personal information.
